4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle C, Title 5, Business & Commerce Code, is
6	amended by adding Chapter 121 to read as follows:
7	CHAPTER 121. SOFTWARE APPLICATIONS
8	SUBCHAPTER A. GENERAL PROVISIONS
9	Sec. 121.001. SHORT TITLE. This chapter may be cited as the
10	App Store Accountability Act.
11	Sec. 121.002. DEFINITIONS. In this chapter:
12	(1) "Age category" means information collected by the
13	owner of an app store to designate a user based on the age
14	categories described by Section 121.021(b).
15	(2) "App store" means a publicly available Internet
16	website, software application, or other electronic service that
17	distributes software applications from the owner or developer of a
18	software application to the user of a mobile device.
19	(3) "Minor" means a child who is younger than 18 years
20	of age who has not had the disabilities of minority removed for
21	general purposes.
22	(4) "Mobile device" means a portable, wireless
23	electronic device, including a tablet or smartphone, capable of
24	transmitting, receiving, processing, and storing information

1	wirelessly that runs an operating system designed to manage
2	hardware resources and perform common services for software
3	applications on handheld electronic devices.
4	(5) "Personal data" means any information, including
5	sensitive data, that is linked or reasonably linkable to an
6	identified or identifiable individual. The term includes
7	pseudonymous data when the data is used by a person who processes or
8	determines the purpose and means of processing the data in
9	conjunction with additional information that reasonably links the
10	data to an identified or identifiable individual. The term does not
11	include deidentified data or publicly available information.
12	SUBCHAPTER B. DUTIES OF APP STORES
13	Sec. 121.021. DUTY TO VERIFY AGE OF USER; AGE CATEGORIES.
14	(a) When an individual in this state creates an account with an app
15	store, the owner of the app store shall use a commercially
16	reasonable method of verification to verify the individual's age
17	category under Subsection (b).
18	(b) The owner of an app store shall use the following age
19	categories for assigning a designation:
20	(1) an individual who is younger than 13 years of age
21	is considered a "child";
22	(2) an individual who is at least 13 years of age but
23	younger than 16 years of age is considered a "younger teenager";
24	(3) an individual who is at least 16 years of age but
25	younger than 18 years of age is considered an "older teenager"; and
26	(4) an individual who is at least 18 years of age is
27	considered an "adult."

Sec. 121.022. PARENTAL CONSENT REQUIRED. (a) If the owner 1 2 of the app store determines under Section 121.021 that an 3 individual is a minor who belongs to an age category that is not "adult," the owner shall require that the minor's account be 4 affiliated with a parent account belonging to the minor's parent or 5 6 guardian. 7 (b) For an account to be affiliated with a minor's account as a parent account, the owner of an app store must use a 8 9 commercially reasonable method to verify that the account belongs to an individual who: 10 11 (1) the owner of the app store has verified belongs to the age category of "adult" under Section 121.021; and 12 13 (2) has legal authority to make a decision on behalf of the minor with whose account the individual is seeking affiliation. 14 15 (c) A parent account may be affiliated with multiple minors' 16 accounts. 17 (d) Except as provided by this section, the owner of an app store must obtain consent from the minor's parent or guardian 18 through the parent account affiliated with the minor's account 19 20 before allowing the minor to: 21 download a software application; 22 (2) purchase a software application; or (3) make a <u>purchase in or using a software</u> 23 24 application. 25 (e) The owner of an app store must: (1) obtain consent for each individual download or 26 27 purchase sought by the minor; and

1	(2) notify the developer of each applicable software
2	application if a minor's parent or guardian revokes consent through
3	a parent account.
4	(f) To obtain consent from a minor's parent or guardian
5	under Subsection (d), the owner of an app store may use any
6	reasonable means to:
7	(1) disclose to the parent or guardian:
8	(A) the specific software application or
9	purchase for which consent is sought;
10	(B) the rating under Section 121.052 assigned to
11	the software application or purchase;
12	(C) the specific content or other elements that
13	led to the rating assigned under Section 121.052;
14	(D) the nature of any collection, use, or
15	distribution of personal data that would occur because of the
16	software application or purchase; and
17	(E) any measures taken by the developer of the
18	software application or purchase to protect the personal data of
19	users;
20	(2) give the parent or guardian a clear choice to give
21	or withhold consent for the download or purchase; and
22	(3) ensure that the consent is given:
23	(A) by the parent or guardian; and
24	(B) through the account affiliated with a minor's
25	account under Subsection (a).
26	(g) If a software developer provides the owner of an app
27	store with notice of a change under Section 121.053, the owner of

2	(1) notify any individual who has given consent under
3	this section for a minor's use or purchase relating to a previous
4	version of the changed software application; and
5	(2) obtain consent from the individual for the minor's
6	continued use or purchase of the software application.
7	(h) The owner of an app store is not required to obtain
8	consent from a minor's parent or guardian for:
9	(1) the download of a software application that:
10	(A) provides a user with direct access to
11	emergency services, including:
12	(i) 9-1-1 emergency services;
13	(ii) a crisis hotline; or
14	(iii) an emergency assistance service that
15	is legally available to a minor;
16	(B) limits data collection to information:
17	(i) collected in compliance with the
18	Children's Online Privacy Protection Act of 1998 (15 U.S.C. Section
19	6501 et seq.); and
20	(ii) necessary for the provision of
21	emergency services;
22	(C) allows a user to access and use the software
23	application without requiring the user to create an account with
24	the software application; and
25	(D) is operated by or in partnership with:
26	(i) a governmental entity;
27	(ii) a nonprofit organization; or

1	(iii) an authorized emergency service
2	provider; or
3	(2) the purchase or download of a software application
4	that is operated by or in partnership with a nonprofit organization
5	that:
6	(A) develops, sponsors, or administers a
7	standardized test used for purposes of admission to or class
8	placement in a postsecondary educational institution or a program
9	within a postsecondary educational institution; and
10	(B) is subject to Subchapter D, Chapter 32,
11	Education Code.
12	Sec. 121.023. DISPLAY OF AGE RATING FOR SOFTWARE
13	APPLICATION. (a) If the owner of an app store that operates in this
14	state has a mechanism for displaying an age rating or other content
15	notice, the owner shall:
16	(1) make available to users an explanation of the
17	mechanism; and
18	(2) display for each software application available
19	for download and purchase on the app store the age rating and other
20	content notice.
21	(b) If the owner of an app store that operates in this state
22	does not have a mechanism for displaying an age rating or other
23	content notice, the owner shall display for each software
24	application available for download and purchase on the app store:
25	(1) the rating under Section 121.052 assigned to the
26	software application; and
27	(2) the specific content or other elements that led to

the rating assigned under Section 121.052. 1 2 (c) The information displayed under this section must be 3 clear, accurate, and conspicuous. Sec. 121.024. INFORMATION FOR SOFTWARE APPLICATION 4 DEVELOPERS. The owner of an app store that operates in this state 5 shall, using a commercially available method, allow the developer 6 7 of a software application to access current information related to: 8 (1) the age category assigned to each user under 9 Section 121.021(b); and 10 (2) whether consent has been obtained for each minor 11 user under Section 121.022. Sec. 121.025. PROTECTION OF PERSONAL DATA. The owner of an 12 13 app store that operates in this state shall protect the personal 14 data of users by: 15 (1) limiting the collection and processing of personal 16 data to the minimum amount necessary for: 17 (A) verifying the age of an individual; 18 (B) obtaining consent under Section 121.022; and (C) maintaining compliance records; and 19 20 (2) transmitting personal data using 21 industry-standard encryption protocols that ensure data integrity and confidentiality. 22 Sec. 121.026. VIOLATION. (a) The owner of an app store 23 24 that operates in this state violates this subchapter if the owner: 25 (1) enforces a contract or a provision of a terms of service agreement against a minor that the minor entered into or 26 27 agreed to without consent under Section 121.022;

8	(b) The owner of an app store is not liable for a violation
9	of Section 121.021 or 121.022 if the owner of the app store:

13	(B) obtain parental consent as required by
14	Section 121.022; and
15	(2) applies those standards consistently and in good
16	faith.
17	Sec. 121.027. CONSTRUCTION OF SUBCHAPTER. Nothing in this
18	subchapter may be construed to:
19	(1) prevent the owner of an app store that operates in
20	this state from taking reasonable measures to block, detect, or
21	prevent the distribution of:
22	(A) obscene material, as that term is defined by
23	Section 43.21, Penal Code; or
24	(B) other material that may be harmful to minors;
25	(2) require the owner of an app store that operates in
26	this state to disclose a user's personal data to the developer of a
27	software application except as provided by this subchapter;

1	(3) allow the owner of an app store that operates in
2	this state to use a measure required by this chapter in a manner
3	that is arbitrary, capricious, anticompetitive, or unlawful;
4	(4) block or filter spam;
5	(5) prevent criminal activity; or
6	(6) protect the security of an app store or software
7	application.
8	SUBCHAPTER C. DUTIES OF SOFTWARE APPLICATION DEVELOPERS
9	Sec. 121.051. APPLICABILITY OF SUBCHAPTER. This subchapter
10	applies only to the developer of a software application that the
11	developer makes available to users in this state through an app
12	store.
13	Sec. 121.052. DESIGNATION OF AGE RATING. (a) The developer
14	of a software application shall assign to each software application
15	and to each purchase that can be made through the software
16	application an age rating based on the age categories described by
17	Section 121.021(b).
18	(b) The developer of a software application shall provide to
19	each app store through which the developer makes the software
20	application available:
21	(1) each rating assigned under Subsection (a); and
22	(2) the specific content or other elements that led to
23	each rating provided under Subdivision (1).
24	Sec. 121.053. CHANGES TO SOFTWARE APPLICATIONS. (a) The
25	developer of a software application shall provide notice to each
26	app store through which the developer makes the software
27	application available before making any significant change to the

1	terms of service or privacy policy of the software application.
2	(b) For purposes of this section, a change is significant if
3	<u>it:</u>
4	(1) changes the type or category of personal data
5	collected, stored, or shared by the developer;
6	(2) affects or changes the rating assigned to the
7	software application under Section 121.052 or the content or
8	elements that led to that rating;
9	(3) adds new monetization features to the software
10	application, including:
11	(A) new opportunities to make a purchase in or
12	using the software application; or
13	(B) new advertisements in the software
14	application; or
15	(4) materially changes the functionality or user
16	experience of the software application.
17	Sec. 121.054. AGE VERIFICATION. (a) The developer of a
18	software application shall create and implement a system to use
19	information received under Section 121.024 to verify:
20	(1) for each user of the software application, the age
21	category assigned to that user under Section 121.021(b); and
22	(2) for each minor user of the software application,
23	whether consent has been obtained under Section 121.022.
24	(b) The developer of a software application shall use
25	information received from the owner of an app store under Section
26	121.024 to perform the verification required by this section.
27	Sec. 121.055. USE OF PERSONAL DATA. (a) The developer of a

1	software application may use personal data provided to the
2	developer under Section 121.024 only to:
3	(1) enforce restrictions and protections on the
4	software application related to age;
5	(2) ensure compliance with applicable laws and
6	regulations; and
7	(3) implement safety-related features and default
8	settings.
9	(b) The developer of a software application shall delete
10	personal data provided by the owner of an app store under Section
11	121.024 on completion of the verification required by Section
12	121.054.
13	(c) Notwithstanding Subsection (a), nothing in this chapter
14	relieves a social media platform from doing age verification as
15	required by law.
16	Sec. 121.056. VIOLATION. (a) Except as provided by this
17	section, the developer of a software application violates this
18	subchapter if the developer:
19	(1) enforces a contract or a provision of a terms of
20	service agreement against a minor that the minor entered into or
21	agreed to without consent under Section 121.054;
22	(2) knowingly misrepresents an age rating or reason
23	for that rating under Section 121.052; or
24	(3) shares or discloses the personal data of a user
25	that was acquired under this subchapter.
26	(b) The developer of a software application is not liable
27	for a violation of Section 121.052 if the software developer:

1	(1) uses widely adopted industry standards to
2	determine the rating and specific content required by this section;
3	and
4	(2) applies those standards consistently and in good
5	faith.
6	(c) The developer of a software application is not liable
7	for a violation of Section 121.054 if the software developer:
8	(1) relied in good faith on age category and consent
9	information received from the owner of an app store; and
10	(2) otherwise complied with the requirements of this
11	section.
12	SUBCHAPTER D. ENFORCEMENT
13	Sec. 121.101. DECEPTIVE TRADE PRACTICE. A violation of
14	this chapter constitutes a deceptive trade practice in addition to
15	the practices described by Subchapter E, Chapter 17, and is
16	actionable under that subchapter.
17	Sec. 121.102. CUMULATIVE REMEDIES. The remedies provided
18	by this chapter are not exclusive and are in addition to any other
19	action or remedy provided by law.
20	SECTION 2. It is the intent of the legislature that every
21	provision, section, subsection, sentence, clause, phrase, or word
22	in this Act, and every application of the provisions in this Act to
23	every person, group of persons, or circumstances, is severable from
24	each other. If any application of any provision in this Act to any
25	person, group of persons, or circumstances is found by a court to be
26	invalid for any reason, the remaining applications of that

27 provision to all other persons and circumstances shall be severed

1 and may not be affected.

2 SECTION 3. This Act takes effect January 1, 2026.
